Thank you for opening our letter. As of our last year's writing, there is so much good news to report that it's hard to know where to begin. We are putting our hearts and souls into our 2020-2025 Strategic Plan [see our enclosed diagram], and as of this writing I am thrilled to tell you that Changing Gaits was awarded a grant from the Christopher & Dana Reeve's foundation to purchase a new lift to work with people with paralysis. We've received new therapists and our volunteer program is booming! I recently told someone that I feel like I'm up in a helicopter looking down at all the good things happening at Changing Gaits. What a view to see Phase I of our plan unfold!

To move forward with the new lift, there is much work to be done before June when Channel 4 News is scheduled at the ranch to share our story of working with people with paralysis. But to prepare for this portion of our strategic plan, Changing Gaits, Inc. needs your help, financially. For our 2021 campaign to be successful we need to raise a minimum of \$64,000. Your generous donations will help fund the following priorities so we can serve more people in need of our faith-based healing therapies:

- <u>Bobcat Track Loader @ \$40,000</u>: This purchase will eliminate expensive rentals for equipment and will be used daily for moving hay, feed, clearing fields, and to excavate land for a new round pen for serving people living with paralysis.
- Excavation/Land Fill and Round Pen @ \$24,000: Land at the ranch needs to be excavated/filled for the purchase of a round pen to ensure safety as we teach improved quality of life skills to our clients with paralysis.
